1. If 3 occurrences of excessive transactions happen within a rolling twelve month period, the account will be changed to a non-interest bearing account.
2. Accounts with balances less than \$50 which have had no activity for 12 months will be charged a dormant fee of \$50 and closed. The Bank may at its discretion close all accounts that are 60 consecutive days with a zero balance. A notice will be sent to the customer when the account is 30 consecutive days with a zero balance.
